Note:-

(1) For Advt. 50/2017-18 to 63-2017-18 out of the above mentioned 71 posts, 02 posts are reserved for Physically Disabled Candidates. Candidate having disability OL (one leg) can apply for Advt.50 to 63 and Candidate having disability B.L.(Both Legs), O.A. (One Arm), O.L. (One Leg), O.A.L.(One Arm and one Leg) B.L.V.(Blind or Low Vision) can apply for Advt.64 The candidates possessing other than the prescribed physical disabilities are not eligible to apply.

(2) The candidates belonging to reserved category can apply against vacancies for Unreserved Category and the criteria will be applicable as per Unreserved Category.

(3) In case of non availability of Women candidates in the respective category, the post so reserved will be allotted to male candidates belonging to the same category.

(4) Selection to the posts of unreserved Category and posts reserved for women candidates thereof Shall be made on the basis of marks obtained in selection process by the candidates of respective categories and also women candidates of that category and on the basis of qualifying standard prescribed by the commission keeping in view to maintain efficiency of respective cadre/service.

(5) Candidates shall carefully read Advertisement No. and Name of Post before Applying online. Candidate shall confirm the application only after verifying the details filled in the application form.

(6) Any request or representation to correct any error or omission in the confirmed online application, or information filled in by the candidate shall not be accepted.

(7) In case of more than one online application made by the candidate, only the latest confirmed application will be considered by the commission. For candidates

belonging to unreserved category the last confirmed application with fees will be considered by the commission.

(8) Candidates shall keep ready the certificates required in case of eligibility for interview (in the order mentioned in general instructions).

Education Qualification and Experience:-

Possess a Post-graduate degree in the relevant subject as shown in the Annexure-I obtained from any of the Universities established or incorporated by or

under the Central or a State Act in India or any other Educational institution recognized as such or declared to be deemed University under section 3 of the University Grants Commission Act, 1956; or posses an equivalent qualification recognized as such by the Central Council Of Indian Medicine:

Provided that if the suitable candidate who possess the post - graduate degree in the concerned subject is not available, a candidate who possesses a post - graduate degree in allied subjects shown against the concerned subject in the Annexure-II or as recognized by the Central Council of Indian Medicine shall be considered for the direct selection.

- The basic knowledge of Computer Application as prescribed in the Gujarat Civil Services Classification and Recruitment (General) Rules, 1967; and
- Adequate knowledge of Sanskrit and Gujarati or Hindi Or Both
- Pay Scale:-Rs.9,300-34,800/- Grade Pay-5,400/-
- Age: Not more than 37 years. Age will be Considered as on last date of application.

Upper Age limit shall be relaxed as under:

1	S.E.B.C, S.T. Candidates of origin of Gujarat	05 Years (maximum up to 45 years)
2	Women Candidates belonging to Unreserved	05 Years (maximum up to 45 years)
3	Women Candidates belonging to S.E.B.C., and S.T. Category of origin of Gujarat	10 Years (maximum up to 45 years)
4	Physically Disabled: : In the case of physically Disabled candidates who are O.L. (One Leg affected) or B.L.(Both Legs), O.A. (One Arm), O.A.L. (One Arm and one leg) and B.L.V.(Blind or Low Vision) O.A. (One Arm affected) of 40% or above and up to 100% shall be considered as suitable for applying in the advertisement, shall get 10 years relaxation in the age limit subject to his / her ability for age relaxation according to Govt. Rules. No relaxation is available to the candidates possessing other than the prescribed physical disabilities.	
5	A candidate who is already in Gujarat Govt service, either as a permanent or a temporary officiating continuously for six months and had not crossed age limit prescribed for the advertised post at the time of his first appointment.	<p>(i) If experience is prescribed as one of the qualifications, the upper age limit shall not apply.</p> <p>(ii) If experience is not prescribed as one of the qualifications and a Govt. servant appointed to a post requiring a Medical, Engineering, Veterinary or Agriculture degree or diploma and who applied for any such post, the upper age limit shall not apply.</p> <p>(iii) If experience is not prescribed as one of the qualifications in the advertisement, Govt. servants who are working on the post from which an employee can be promoted to the post so advertised, be entitled to relaxation of 5 years, or to the extent of equal number of years for which service has been put in by him, whichever is less.</p>
